#### on California Ballot Measures for the November 6 Election

#### **Proposition 30 – Support**

Temporary Taxes to Fund Education. Guaranteed Local Public Safety Funding. Initiative Constitutional Amendment.

#### Proposition 31 – No Position

State Budget. State and Local Government. Initiative Constitutional Amendment and Statute.

#### Proposition 32 – Oppose

Political Contributions by Payroll Deduction. Contributions to Candidates. Initiative Statute.

#### Proposition 33 – No Position

Auto Insurance Companies. Prices Based on Driver's History of Insurance Coverage. Initiative Statute.

#### Proposition 34 – Yes

Death Penalty. Initiative Statute.

#### **Proposition 35 – Neutral**

Human Trafficking. Penalties. Initiative Statute. (For further information, please view SPA's statement regarding Prop 35 at our website www.ncjwsf.org)

#### **Proposition 36 – Yes**

Three Strikes Law. Repeat Felony Offenders. Penalties. Initiative Statute.

#### **Proposition 37 – No Position** Genetically Engineered Foods. Labeling. Initiative Statute.

**Proposition 38 – No** Tax to Fund Education and Early Childhood Programs. Initiative Statute.

**Proposition 39 – No Position** Tax Treatment for Multistate Businesses. Clean Energy and Energy Efficiency Funding. Initiative Statute.

**Proposition 40 – Proposition Withdrawn** Redistricting. State Senate Districts. Referendum.

Advocacy at the State Level: Most states with NCJW sections have SPAs who are appointed by the NCJW president. SPAs monitor issues at the state level, represent NCJW on state coalitions, act as contacts on federal issues, communicate with local sections to update them on state and federal issues, and serve as advocacy resources to section. Our California SPA chairs are Lydia Inghram, Claire Lipschultz (NCJWSacramento) and Nancy Wolman (NCJW San Diego).

#### Roles and Responsibilities of the NCJW Board of Directors

Excerpted from Linda Frank's Installation Speech, August 2, 2012:

Directors: Your specific roles may vary, but your fundamental duties are not insignificant. They include educating yourself on the workings of Section business, contributing to the planning and implementation of Section activities, committee service and representing NCJW and the SF Section in the communal arena. Legally, you bear responsibility and potential liability for the financial and legal actions of the Section. Ignorance is no excuse. Your role as fiduciaries, trustees literally, mandates that you ask questions and operate in a manner that reflects the highest ethical standards that Judaism and the law demand. Embrace your duties with enthusiasm, creativity and respect for your colleagues. Work as a team. You are hereby installed. Mazel tov!

Teamwork, enthusiasm, creativity, respect for colleagues—these are attributes that of course also pertain to officers. In addition, you have very specific duties.

The treasurer as the primary financial fiduciary needs to guide, along with staff, the process of formulating a budget and insuring that it's adhered to. Policies and procedures spell out roles and responsibilities of both professionals and volunteers, but it's the volunteer treasurer whose oversight ultimately counts.

Secretarial adherence to accurate recordkeeping leaves no doubt as to board decisions and the processes that lead to them. Vice-Presidents best support the president but should themselves assume responsibility, per her direction, for specific portfolios reflecting the needs of Section operations. These can include membership, fund raising, program whatever areas result from a visionary, yet realistic, process of board planning and strategy.

And Mme. President—as the ultimate Section leader you're the overseer of virtually all the other positions. I don't have to tell you how important this is. But equally important is your role in setting the tone and the outlook as your board begins its very important work of taking the San Francisco Section to a new level of achievement consistent with the core values of NCJW. Antonia, you've demonstrated a high level of commitment and advocacy skill in your work on human trafficking, as well as the heart that goes along with it—an ideal combination for a successful NCJW Section president.
